

# VOLLEYPALOOZA MIDDLE SCHOOL VOLLEYBALL FESTIVAL

## TEAM CONTRACT FOR THE 2025 EVENT

This contract was made and entered into on the \_\_\_\_ day of \_\_\_\_\_, 2025, between the school authorities in control of Interscholastic Athletics at (hereinafter Tournament Participant) and the Volleyball Program at Ironwood Ridge High School stipulates the following:

- 1) That the Middle School Volleyball team(s) representing \_\_\_\_\_ shall compete in the **Volleypalooza Middle School Volleyball Festival**, to be held on **April 4-5, 2025**, at **Ironwood Ridge High School in Oro Valley, Arizona**.
  
- 2) The **Tournament Entry Fee of \$ \$300 per team** (or \$275 per team when registering 8th/7th Grade Teams together) **will be payable to Ironwood Ridge Volleyball**, and the Ironwood Ridge High School Bookstore shall receive it on or before **April 2, 2025**.  
*Purchase Orders will be accepted before March 14, 2025, to secure registration.*  
*Volleypalooza Fee Schedule: One Team: \$300; Two Teams: \$550; Three Teams: \$750*
  
- 3) **The Tournament Participant agrees with the following policies and procedures:**
  - a. The Tournament Committee shall have sole responsibility for the tournament format.
  - b. The Tournament Committee will seed the field in groups that best match the strength and ability of the participating teams.
  - c. The Tournament Participant agrees to play in all matches set forth in the schedule.
  - d. The Tournament Participant is guaranteed at least five (5) pairs matches
  - e. **The Tournament Participant agrees to have a school-board approved coach at each site during the competition.** Failure to provide an approved coach will result in the team being disqualified.
  - f. The Tournament Participant agrees to informing all school spectators (parents, family members, students, etc.) of the Spectator Code of Conduct – found on the tournament website.
  
- 4) For this contract to be valid, the Tournament Participant must sign and return it to the Tournament Director on or before **March 14, 2025**. The Tournament Participant must also understand and agree that this contract will bind them to the above agreements. The tournament cannot revoke this contract once both parties have signed it.
  
- 5) The term of this contract shall be from the date of execution until the tournament's conclusion on Saturday, April 5, 2025.
